The Office of the City Clerk is accepting applications from Cerritos residents interested in appointments to fill unscheduled vacancies for the remainder of the unexpired two-year term of service on the following Cerritos Advisory Board:

City Celebrations Committee* – Three (3) positions

- Description:** Reviews matters related to the planning of Citywide special events, including the Festival of Friendship, Halloween Festival, Let Freedom Ring (Independence Day) Celebration, Santa’s Sleigh Day, Spring Fling and Fireworks Spectacular, UbeFest, and Water Lantern Festival
- Qualifications:** Cerritos resident (Ordinance No. 1058)
- Councilmember:** The nominations to fill these positions will be made by Mayor Yokoyama, Mayor Pro Tem Johnson, and Councilmember Jennifer Hong.
- Monthly stipend:** \$25 (optional) (Resolution No. 2025-39)
- Mileage:** IRS Mileage Reimbursement Rate (Resolution No. 2025-39)
- Meetings:** 4th Wednesday of January, March, May, June, and August, and 2nd Wednesday of December, 7:00 p.m.
- Requirements:** Newly appointed members of the City Celebrations Committee will be required to participate in and complete the 2026 L.E.A.D. Cerritos, civic leadership program, which is currently underway. Visit cerritos.gov/lead for more information about this program.

Pursuant to California Government Code Section 54974(a), appointments to fill these vacancies can occur at a publicly noticed City Council meeting held on or after March 23, 2026. All appointments are subject to City Council majority vote.
