

**City of Cerritos

Materials from your job site can be recycled. The City of Cerritos Municipal Code requires you to recycle or reuse a minimum of 50% of your project's waste. The City has an exclusive franchise agreement with Athens Services for construction and demolition waste removal services. By using Athens Services, you will have met your 50% waste diversion requirement. To contact Athens Services, please call (833) 791-2376. If you self-haul materials from the jobsite, and your project is 900 square feet or greater in size, you will be required to demonstrate that you have diverted 50% of your project's waste from landfill disposal.

**Step 1: Before your Project Begins:** Complete this form.

- If your project is less than 900 square feet in area, check this box. You are exempt from further compliance with the City of Cerritos' C&D Debris Diversion Ordinance.
- If you will be contracting with Athens Services for your project's waste hauling services, check this box. You are exempt from further compliance with the City of Cerritos' C&D Debris Diversion Ordinance.
- If your C&D waste will be hauled by anyone other than Athens Services, and your project is 900 square feet or more in area, check this box. You are required to submit a Performance Security Deposit in the amount of \$.50 per square foot of project size along with this form and divert 50% of project waste from landfill disposal. Please proceed to Steps 2, 3 & 4.

**Step 2: While your Project Progresses:** *(self-haul projects of 900 square feet or greater only)*

Save all weight receipts and/or documentation from disposal sites including recycling centers, landfills and jobsite reuse.

**Step 3: Before final inspection:** *(self-haul projects of 900 square feet or greater only)*

Complete Part 2 of this form and submit receipts/documentation (original or certified photocopies) verifying that a minimum of 50% of the debris or material generated was diverted from landfill disposal.

**Step 4: Deposit Returned:** *(self-haul projects of 900 square feet or greater only)*

Within 30 days of submittal of final documentation, your performance security deposit will be returned. If it is determined that a minimum of 50% of C&D materials were not recycled, a prorated portion of your deposit will be returned.

**Construction & Demolition Debris Diversion Requirement**  
**“Facts-at-a-Glance”**

According to recent studies, Construction and Demolition debris accounts for nearly 22 percent of the waste stream in California. A significant portion of these materials can be reused or recycled, thus prolonging our supply of natural resources and landfill capacity. Consequently, the Cerritos City Council adopted a Construction & Demolition (C&D) Debris Diversion Ordinance in December 2007.

Complying with the requirements of the ordinance is easy:

**Step 1 – Complete Part 1 of the C&D Waste Management Plan**

- If you need to contract for roll-off or bin services, contact Athens Services at (833) 791-2376. Athens processes all C&D materials that it collects to salvage recyclable material. Contracting with Athens Services for your project’s waste hauling services automatically brings you into compliance with the City’s C&D Ordinance. Simply complete Part 1 of the Waste Management Plan and you are finished.
- If your project is less than 900 square feet it is exempt from the City’s C&D Ordinance. Simply complete Part 1 of the Waste Management Plan and you are finished.
- If your C&D waste will be hauled by anyone other than Athens Services, and your project is 900 square feet or more in area, a Performance Security Deposit in the amount of \$.50 per square foot of project size will be required, and you will be responsible for recycling at least 50% of the C&D waste generated from your project. Complete Part 1 of the Waste Management Plan and move to Steps 2 & 3.

**Step 2 – Save your receipts**

- As your project progresses, save all receipts from any facility (both recycling and landfill) which you take materials generated on your project site. Documentation will also be required of materials which were taken for reuse to another jobsite.

**Step 3 – Complete Part 2 of the C&D Waste Management Plan**

- Upon completion of your project, submit Part 2 of the Waste Management Plan. Attach receipts from both recycling and landfill facilities and/or documentation from jobsite reuse.

**Step 4 – Deposit Returned**

- Within 30 days of submittal of final documentation, your performance security deposit will be returned. If it is determined that a minimum of 50% of C&D materials were not recycled, a prorated portion of your deposit will be returned.
